



Layout plan





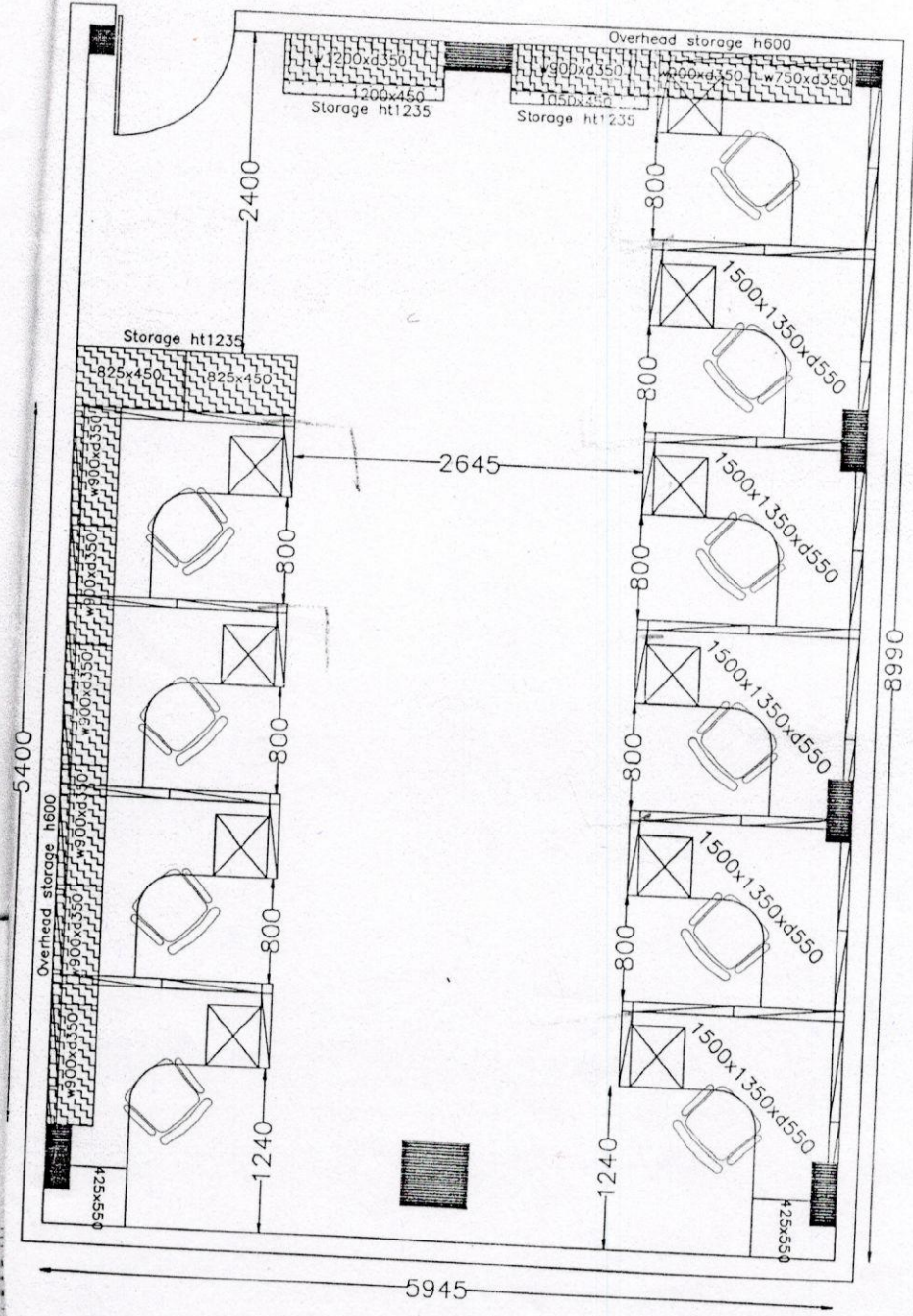
